Provide safe access and lighting where required.

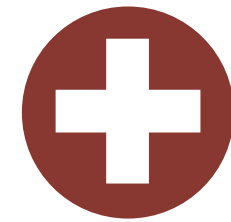

INDUCTION PROCEDURES

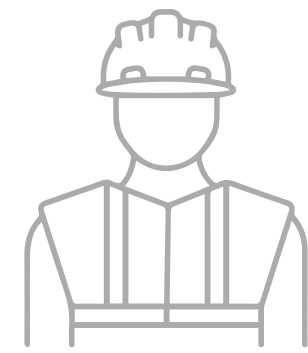
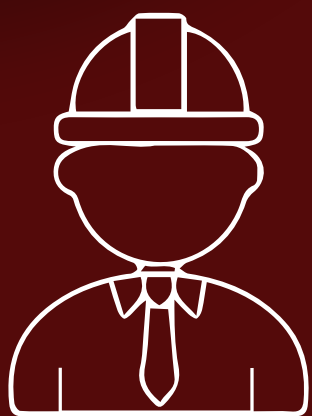
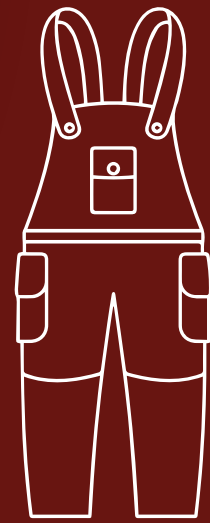
Each new and/or transferred employee shall attend a safety training induction meeting during the first week after their arrival on the project.

The induction meeting will be chaired and presented by the Project Manager and/or Safety Officer, plus Supervisors and Foremen.

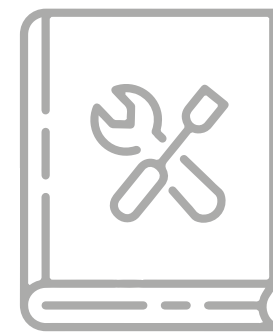
The following items shall be reviewed with each new employee:

- 4 Define the employee's responsibility.

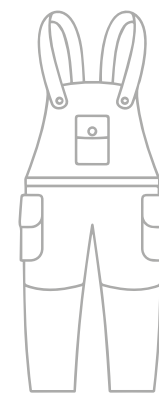
PERSONAL PROTECTIVE EQUIPMENT



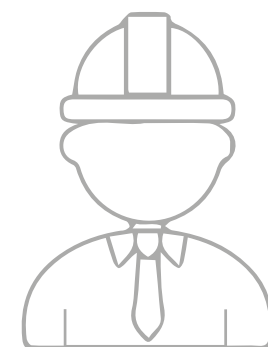
All employees are required to wear at all times safety helmet, foot protection and safety gloves in designated areas on the project. Employees shall be informed that all other items of personal protective equipment, such as face protection, respiratory protection, safety belts and lifelines, hearing protection etc. will be made available when required.



The use and maintenance of personal protective equipment shall be explained.



Manual employees shall wear the coveralls provided by Company during the work hours, and any additional protective clothing to assist in providing a shield from the sun rays.



All visitors to the site shall abide with the instructions and requirements regarding the wearing of personal protective equipment when entering the work area.

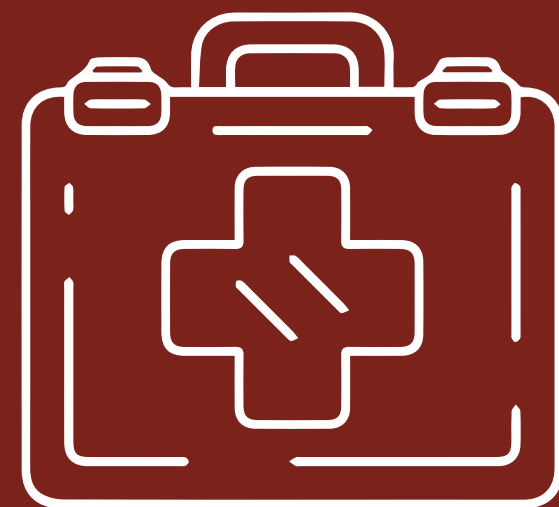
HOUSEKEEPING



Good housekeeping is a vital part of the Company safety program. It is the responsibility of all the employees - Managers, Supervisors and workers to practice good housekeeping. The work areas must always be clean and tidy, thus reducing risk from fire or other accident.

MEDICAL & FIRST AID FACILITIES

First aid kits are provided for the safety of all personnel. Qualified personnel must be available to render treatment and to maintain required records.



1

All injuries, no matter how minor, must be reported to the Foreman immediately.

2

Foreman must be notified prior to any person leaving the job site because of injury or illness, whether personal or work related.

3

Injured or seriously ill persons at the job sites will be transferred to hospital.

PORTABLE POWERED TOOLS & EQUIPMENT

VEHICLES & MOBILE PLANT

1

Vehicle and plant will only be driven by those persons licensed, authorized and trained to do so, in accordance with the statutory requirements of the State of Qatar in which the project is being built. Operators shall be fully familiar with the manufacturer instructions for the vehicle or plant being operated.

2

Those items of mobile plant which are involved in reversing (trucks, loaders, dump trucks, dozers ... shall be fitted with an audible reversing warning system.

3

All fuel powered equipment must be shut down while being refueled. except in the case of specialized or heavy equipment where this is contrary to the manufacturers recommendations. Smoking is prohibited during refueling operations and other nearby sources of ignition such as burning and welding must also be halted during refueling operations.

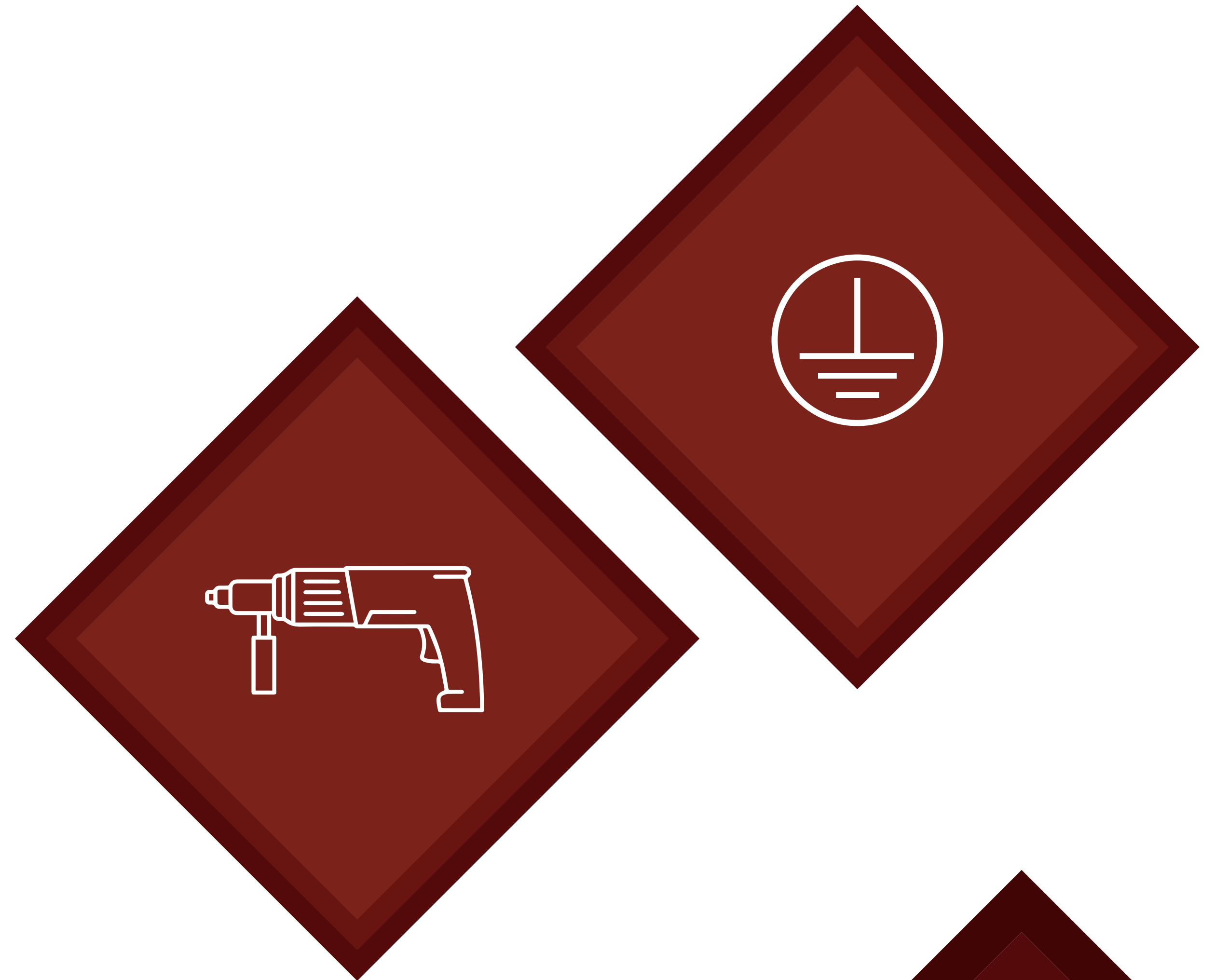
PORTABLE ELECTRICAL EQUIPMENT'S

1

All electrical equipment must comply with the Statutory Regulations for the State of Qatar in which the project is being built. It shall also comply with all client requirements.

2

Electrical tools and equipment shall be provided with adequate protection including earth leakage services to ensure safety of all personnel.
